

23rd Asia-Pacific Training Workshop (APTW) on EIU/GCED

Expanding the Vision of Peace through GCED

19-28 June 2024 / Online

Overview

In today's complex and interconnected world, the pursuit of peace transcends the mere absence of armed conflicts, encompassing a holistic vision of societal harmony, justice, and sustainability. This vision is encapsulated in UNESCO's "Recommendation on Education for Peace and Human Rights, International Understanding, Cooperation, Fundamental Freedoms, Global Citizenship and Sustainable Development (2023)," revised from the 1974 Recommendation. The revised recommendation also posed a greater call on Global Citizenship Education (GCED), highlighting its role in cultivating a culture of peace and sustainable development.

Drawing on the transformative potential of GCED as highlighted by UNESCO, the 23rd Asia-Pacific Training Workshop (APTW) on EIU/GCED is designed to empower educators from the Asia-Pacific region to become catalysts for positive change in their communities and beyond. Especially paying special attention to the comprehensive understanding of peace, which encompasses not only the resolution of conflicts but also the promotion of social justice, environmental sustainability, and inclusive development, participants will be empowered to creatively address the multifaceted challenges of today's world as global citizens.

As APCEIU's flagship Training of Trainers (TOT) programme, the APTW will engage educators through a blend of theoretical insights and practical applications. Through a curated series of lectures, interactive workshops, and group discussions, the workshop offers both foundational knowledge and actionable strategies. These include innovative pedagogies and practical methods for integrating GCED into teaching practices and curricula, equipping participants with the necessary tools to implement contextualized educational programmes that contribute to peace.

Furthermore, the 2024 APTW will include a comprehensive post-workshop mentorship programme led by experts. This programme is designed to support participants in implementing tailored GCED projects that address local and regional needs. By doing so, the workshop not only enhances the capabilities of individual educators but also aims to ripple outwards, enriching and fostering global citizenship within and across communities. Through these efforts, the workshop aims to cultivate a more peaceful, just, and sustainable world, echoing the transformative spirit of the 2023 UNESCO recommendation.

- To introduce innovative approaches to teaching and learning reflecting the pedagogical principles of GCED
- To strengthen participants' capacity to carry out GCED activities in the local contexts

Eligible candidates must fulfil the following requirements:

- 1. Be a professional educator from the UNESCO Member States in the Asia-Pacific region
- 2. Have a minimum 3-year career experience (formal, informal and non-formal included)
- 3. Have <u>commitment and capacity to implement GCED training programmes within 3 months</u> <u>after participation in the workshop</u>
- 4. Be proficient in spoken and written English
- 5. Have the necessary equipment, such as a computer and stable access to the internet, to attend the online workshop
- 6. Complete the prerequisite e-learning course on GCED Online Campus before the application deadline (Course Certificate must be attached to the application)*
